- A Liquor Licence may be required from the Department of Racing, Gaming and Liquor (DRGL) for the sale, supply or service of alcohol in compliance with the Liquor Control Act 1988. A copy of any Licence is to be given to the Shire of Donnybrook-Balingup before an event. Contact DRGL for further information on 1800 634 541 or visit www.rgl.wa.gov.au It is advised that applications for Liquor Licences be lodged with DRGL as early as possible. The local Police Station is also able to provide information regarding DRGL Licences;
- **All bookings of Shire facilities are TEMPORARY until a Liquor Permit Request is assessed and a Shire Liquor Permit is issued. Applications for the consumption of alcohol may be refused and a Permit revoked at any time.**
