#### 8.1 COMMUNITY EMERGENCY SERVICES MANAGER

- There has been a significant increase of approximately \$90k to this year's ESL grant
- Elected FCOs are encouraged to raise any issues at BFAC Meetings
- Vehicle/Building/PPE maintenance issues are to continue to be forwarded to CESM
- Increase in State Mitigation Funding, Shire has also contributed
- 3 Casual Mitigation Officers have commenced employment at The Shire to carry out the Mitigation Program
- Training Courses held to date include two Introduction to Firefighting and two Bush Firefighting Courses
- Requested that all Bushfire Brigade members update their details on the Volunteer
  Portal
- Callout Procedure Most Brigades are now on Group Call and SMS. Three Brigades are now Trialing the BART system Update to be provided at next BFAC Meeting
- Donnybrook Emergency Services exercise was a success
- Burning Permits Permit holder is to contact DFES CommCen, no longer required to notify The Shire
- Shire of Donnybrook Balingup IMT structure has been updated most FCOs now hold functional roles
- The SES building will be utilised as an ICC for incidents with more than two brigades in attendance this fire season.
- FCOs to be issued dress uniform

#### 8.2 RANGER SERVICES

Firebreak inspections are due on 1 December 2018. Ranger Services will commence preinspections in November to will make contact with potentially non-compliant residents. FCOs are requested to notify Ranger Services of any properties of concern.

#### 8.3 CHIEF BUSH FIRE CONTROL OFFICER

- Approximately 30 incidents have occurred since April 2018. These have mostly been as a result of escaped burns.
- Permit Season starts 1 November 2018.
- Roll call will commence November 5 at 06:45 on Mondays, Wednesdays and Fridays.
- When responding to incidents, brigades are to notify either Donnybrook Chief, Ferndale Station or Donnybrook CESM. Please radio upon departure, arrival, and return to base.
- Thank you to Tyler for your commitment and dedication to all brigades while in the position of CESM.
- Thanks to Jess for taking on the position of acting CESM.
- Last Saturday's Emergency Exercise in Donnybrook went well.
- Looking forward to working with you all in the 2018-2019 season.

#### 8.4 DEPARTMENT OF FIRE AND EMERGENCY SERVICES

- Several regional staffing changes to the Lower South West
  - o Phil Brandrett A/Superintendent
  - o Steve Ward A/District Officer
  - o Chris Sousa A/Area Officer South
- Seasonal Outlook for this fire season Shires of Donnybrook Balingup, Boyup Brook and Kojonup are expected to experience above average fire behaviour
- Donnybrook enhanced response zone is currently under review, minor changes to take place
- 400Mhz radio project has been rolled out please check all radios have been updated
- Rescue 652 channel has changed to 220ESC
- Westbay Fire Post Incident Report key finding regarding asbestos. Please activate Fire and Rescue immediately if present as incident becomes HAZMAT
- Fuel sampling has commenced for several planned mitigation burns, very low fuel moisture content discovered

#### 8.5 DEPARTMENT OF BIODIVERSITY CONSERVATION AND ATTRACTIONS

- Thanks to The Shire of Donnybrook Balingup Bush Fire Brigades for assistance at incidents this year.
- There has been 22 deliberately lit fires between Donnybrook and Capel this year.
- Asbestos has been located in the block behind the Shire Pound.
- 9,700 Hectares were burned in the Blackwood District during Autumn Burning Program.
- 450 Hectares within the Munro block are planned to be burned in the Spring Burning Program.
- 30 Hectares near Noggerup Town site are also planned to be burned in the Spring Burning Program.

#### 9 OTHER BUSINESS

#### 9.1 COMMUNICATIONS TRAILER

- Ian Ralph provided an update on the trailer's progress. It has been collected and is currently awaiting electrical work to be completed.
- \$600 has been received from other brigades
- The trailer is currently housed at the Donnybrook SES and can be activated by calling the SES duty phone.
- Requested two DFES-funded WAERN radios for the trailer.

#### 9.2 PRIVATE VEHICLES AT FIRES

 Max Walker requested that the details of any private vehicles in attendance at fires be provided to him. FCOS are to provide direction to private vehicles at incidents
